




# Q3 How many employees does your business employ in Scotland?


# Q4 How has your business been directly impacted as a result of the coronavirus crisis? Tick all that apply



#### Q5 What impact has COVID-19 crisis had on your staff? Tick all that apply





# Q6 What payment issues have you faced from Public sector clients (Councils, NHS etc) Tick all that apply





#### Q7 What payment issues have you faced from Private sector clients?








# Q9 What actions would you like to see Scottish government take? Tick all that apply


